The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 6,070.2 million square meter equivalents (MSME) in August 2016, a decline of 2.5 percent compared to August 2015. Imports of textiles were 3,337.4 MSME in August 2016, down 1.0 percent from August 2015. Imports of apparel were 2,732.8 MSME in August 2016, down 4.3 percent from August 2015.

Imports of textiles and apparel were 41,765.0 MSME for the year-to-date August 2016, a decline of 2.0 percent from year-to-date August 2015. Imports of textiles were 23,904.2 MSME for the year-to-date August 2016, a decline of 2.6 percent from the year-to-date August 2015. Apparel imports for the year-to-date August 2016 were 17,860.8 MSME, down 1.1 percent from the year-to-date August 2015.
