The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 4,549.6 million square meter equivalents (MSME) in November 2014, an increase of 2.2 percent compared to November 2013. Imports of textiles were 2,723.9 MSME in November 2014, up 4.6 percent from November 2013. Imports of apparel were 1,825.7 MSME in November 2014, down 1.2 percent from November 2013.

Imports of textiles and apparel were 54,714.0 MSME for the year-to-date November 2014, an increase of 4.7 percent from year-to-date November 2013. Imports of textiles were 30,983.7 MSME for the year-to-date November 2014, an increase of 5.9 percent from the year-to-date November 2013. Apparel imports for the year-to-date November 2014 were 23,730.2 MSME, up 3.1 percent from the year-to-date November 2013.
