The Office of Textiles and Apparel reported today that imports of cotton, wool, man-made fiber, silk blends, and non-cotton vegetable fiber textile and apparel products totaled 5,601.9 million square meter equivalents (MSME) in October 2015, a decrease of 1.7 percent compared to October 2014. Imports of textiles were 3,130.3 MSME in October 2015, down 3.0 percent from October 2014. Imports of apparel were 2,471.6 MSME in October 2015, remaining flat from October 2014.

Imports of textiles and apparel were 54,032.9 MSME for the year-to-date October 2015, an increase of 7.7 percent from year-to-date October 2014. Imports of textiles were 30,816.5 MSME for the year-to-date October 2015, an increase of 9.0 percent from the year-to-date October 2014. Apparel imports for the year-to-date October 2015 were 23,216.3 MSME, up 6.0 percent from the year-to-date October 2014.
