

Subject: Request to Modify the Rule of Origin under the U.S.-Bahrain Free Trade Agreement

Dear Mr. Vaughn,

On behalf of the Kingdom of Bahrain, I am writing to request your assistance in taking appropriate action under the terms of the U.S.-Bahrain Free Trade Agreement ("FTA") to modify the applicable rules of origin for certain apparel articles using specific third-country fabrics due to a lack of commercial availability in the territory of the two parties.

In this regard, we request immediate consultations to amend the rules of origin, in accordance with the provisions of Article 3.2.3 of the FTA.

With the expiry of the Tariff Preference Level ("TPL") on July 31, 2016, the Bahrain textile and garment industry lost the benefit granted by this arrangement. This expiration impeded the apparel industry, which employed some 5000 people (mostly women), in our country with a population of just over 1 million people. Indeed, the loss of these jobs will be harmful for the Bahrain economy as a whole.

This request is being made with regard to a list of thirty five fabrics that we understand are not available within the United States or Bahrain within the terms of Article 3.2.4. This request for immediate consultations are based on the commercial needs of producers in Bahrain, including MRS, Ambattur and Noble. The specific list of fabrics for which we are requesting consultations, including item description, Fabric HTSUS & End Use HTSUS, are found in the Annex enclosed with this letter.

As mentioned above, given the impeded expiry of the TPL on July 31, 2016, we request that consultations under Article 3.2.3 be conducted in a timely manner, and that they take no longer than the 60 days specified in Article 3.2.5. This is of critical importance to the Kingdom of Bahrain, as we endeavor to revive the big influence of the apparel industry to our national economy from the loss of the TPL benefits.

We appreciate your attention to this matter and I am available to discuss with you anything related to this request for consultations to change the rule of origin related to these fabrics.
